It is a new, exciting year for children's representation in the State of Washington and I am excited to announce that we have staffed our second cohort of counties mandated to be operational under 2SHB 1219, codified at RCW 13.34.212. As of January, all children 8-17 in dependencies and all children 0-17 whose parents are subject to termination proceedings in Benton, Franklin, Yakima, Walla Walla, and Kittitas counties will have (subject to the assignment procedures delineated in RCW 13.34.212) quality legal representation at public expense.

I would also like to extend a warm welcome to the attorneys who will be representing kids in the abovenamed counties: Michelle Trombley, Susan Henwood, Kathleen Moreno, Paula Davenport, Cathy Busha, Ryan McPherson, Ify Amadioha, Brandon Crawford, Kindra Crawford, Bridie Hood, Bailey Black, Sarah Duross-Porto and Jayson Thibodaux. In addition, we have hired Jeffrey Adams as our CRP Training Coordinator. His experience and enthusiasm are a welcome addition to our growing team, and we are eager to announce our training initiatives and opportunities in the coming months.

### WA STATE WORKING FAMILIES TAX CREDIT
